Public health expert Consultant (m/f)

This posting concerns a short-time assignment of about 10 days working for Welthungerhilfe in a freelance capacity.

Objectives and responsibilities of the position

The objective of the consultancy is to assess and provide input on appropriateness of the designs to the needs and requirements of the targeted population, compliance to national and international public health standards and guidelines for construction of health facilities and assess integration of public health measures that eliminate public health hazards to patients, health personnel and the general population .

Your most important duties are as follows:

- Review the floor plans/designs for each level of public health facility intended to be constructed by the project (public health clinic 2, health facility and county health hospital)
- Identify and recommend necessary adjustments /improvements of the floor plans to address the short comings identified
- Undertake a final check of the finalized designs after incorporation of technical inputs from the public health expert to ensure proposed requirements /changes have been incorporated into the final floor plans.
- Review the extent in which the floor plans consider and integrate elements such as flow of people, medical wastes both solid and liquid, reduction cross contamination risks in high risk places, airflow and other critical public health issues.
- The consultant shall produce a consultancy report with recommendations of not more than 5 pages.

Your qualifications will include:

To be considered for this position you must submit the following documents or give evidence of the following criteria:

- A bachelor's degree in public health or related field. (CV)
- 3-5 years of previous experience in construction of health facilities in developing countries (CV)
- Similar experiences or related contracts within the last 5 years (minimum 3 references)
- 3-5 years of regional experience in west Africa specifically in the health sector
- More than 3 years' experience in Medical wastes both solid and liquid, reduction cross contamination risks, airflow, etc. (CV)
- Proof of professional registration and taxation

Your requirements will include:

- Financial offer, budget incl. fees/honorarium per working day, travel costs, accommodation, per diems all as a lump-sum
- Financial offer in Euros detailing costs for the assignment, broken down into reimbursable and miscellaneous costs for a maximum of 10 days with budget of no more than 5000 euros.
- Technical offer detailing a brief methodology for performing the services based on TOR; workplan, and a summary of your experience in similar assignments. The methodology shall be evaluated and weighted based on its clarity, completeness, fulfillment of the TOR requirements, methods proposed and workplan of not more 10 days for the assignment.
